# The CCF Prep Class

The purpose of this class is to give applicants and prospective applicants insight into how the exam will be administered, what to study, and what will be expected of them.

The demonstration portion of this class is intended to show applicants the quality of workmanship that the judges will be looking for and to give an introduction to the different parts of the exam and the schedule of the exam itself.

The workshop portion of this class is intended to demonstrate the required level of craftsmanship and quality for the hands-on part of the exam. It is expected that the partici-

pants have already attained a basic level of knowledge and skill development.
